Net Control Script

First and Third Monday Night of Each Month at 19:00 Local.

- “**QST, QST, QST!** CALLING THE GARFIELD COUNTY AMATEUR RADIO EMERGENCY SERVICE NET”. (REPEAT)
- “THIS IS (**YOUR CALL**), NET CONTROL STATION FOR THIS EVENING AND MY NAME IS (**YOUR NAME**). I AM LOCATED IN ENID OKLAHOMA. “
- “IS THERE ANY EMERGENCY OR PRIORTITY TRAFFIC ON THIS FREQUENCY”?
- CALL FOR A BACKUP NET CONTROL OPERATOR.
- “THE PURPOSE OF THIS NET IS TO FURNISH EMERGENCY COMMUNICATIONS WHEN REGULAR COMMUNICATIONS FAIL OR BECOME INADEQUATE DURING NATURAL OR MAN-MADE DISASTERS FOR THE JURISDICTIONS AND AGENCIES WITHIN **GARFIELD COUNTY**”.
- “THIS NET ALSO PROVIDES THE OPPORTUNITY FOR MEMBERS TO RECEIVE INFORMATION AND TRAINING THAT WILL HELP IN RESPONDING WHEN NEEDED.”
- “THIS NET IS SCHEDULED THE FIRST AND THIRD MONDAY NIGHTS OF EACH MONTH AT 19:00 LOCAL TIME ON THE 145.290 REPEATER”.
- “THIS IS A ROLL CALL NET. THE MEMBERS OF THE GARFIELD COUNTY ARES WILL BE CONTACTED FIRST. IF YOU HAVE ANY ANNOUNCMENTS OR COMMENTS ADVISE NET CONTROL WHEN YOU ARE CALLED. ALL OTHER STATIONS ON FREQUENCY WISHING TO PARTICIPATE PLEASE STAND BY”.
- CONDUCT ROLL CALL NET.
- “THIS CONCLUDES THE ROLL CALL FOR THE GARFIELD COUNTY ARES MEMBERS. WE WILL NOW TAKE CHECK-INS FROM OTHER STATIONS ON FREQUENCY. WHEN CHECKING IN, PLEASE KEY YOUR MIKE AND SAY “THIS IS”, UNKEY YOUR MIKE TO MAKE SURE YOU HAVE THE REPEATER, KEY YOUR MIKE AGAIN AND GIVE YOUR CALL SIGN PHONETICALLY”.
- LIST CHECK-INS AND ACKNOWLEDGE EACH.

NET CLOSING

- “THIS IS (**YOUR CALL**) THANKING EACH STATION FOR PARTICIPATING WITH THE NET TONIGHT”.
- “THIS CONCLUDES THE GARFIELD COUTNY A.R.E.S. NET AT (**MILITARY TIME**) AND RETURNING THIS REPEATERS TO REGULAR AMATEUR USE”.
